3] The door step service is possible only within one way distance of maximum 10 Kms from IDTR Pune.

4] The course must be finished within 60 days maximum.

5] The payment to government authorities for LLR and PDL related activities shall be directly by the candidate, apart from the fees paid to IDTR Pune.

6] Visits to RTO offices shall be by the customer at his/ her cost.

7] IDTR Pune shall help fully and guide for getting LLR and PDL, like slot booking, online payment, advise on documents etc. subject to eligibility of the candidate as per government norms. Holding at least a valid LLR is must for driving practice sessions. Dispatch of PDL is not under IDTR Pune scope. The follow up is to be done by the candidate with the RTO. Also, the rent of test vehicle for PDL test will be paid by the candidate. Vehicle for PDL test can be arranged by IDTR Pune, only at Pune or PCMC test track, at request, subject to availability for the same.
